Independent Auditor's Report on the audit of the interim condensed consolidated financial statements

For the General Meeting of Shareholders and the Supervisory Board of the Company CCC S.A. [a joint-stock company]

Introduction

We have audited the enclosed interim condensed consolidated financial statements of the Capital Group CCC Company Spółka Akcyjna (hereinafter referred to as the "Group") in which CCC S.A. is the parent company (hereinafter referred to as the "Company") with its registered office in 59-101 Polkowice, ul. Strefowa 6, made on 30th June 2017, including: interim condensed consolidated statement of financial position as at 30 June 2017; interim condensed consolidated statement of profit and loss and other comprehensive income and interim condensed consolidated statement of cash flows, interim condensed consolidated statement on changes in equity for the period of 6 months finished on 30th June 2017 as well as selected explanatory information ("interim condensed consolidated financial statements").

The Management Board of the Company is responsible for the preparation of the interim condensed consolidated financial statements in accordance with the International Financial Reporting Standards concerning *interim reporting (IFRS 34)*, approved by the European Union. Our responsibility was to make a conclusion referring to the enclosed interim condensed financial consolidated statements based on the audit executed by us.

Scope of the review

We performed the audit according to applicable provisions of the regulations of International Standard of Review Engagement 2410, *review of interim financial data executed by the individual auditor of the entity* ("a standard"). The review of the interim financial statements is based on making inquiries, mainly, to the people responsible for financial and accounting issues and on making analytical procedures as well as other review procedures. The review is significantly narrower than the audit conducted in accordance with the International Standards on Auditing and as a result, the review does not enable us to be certain that we have identified all significant issues that could be identified in case of making the audit. Due to this fact, we do not express an opinion on the enclosed interim condensed consolidated financial statements.
