

The change of an established mortgage

The Board of CCC S.A. hereby informs that on 5 March 2013 the Company received a notification from the V Land and Mortgage Division of the District Court in Lubin, dated 27 February 2013 to the changes of registration, concerning bail mortgages in the Books of Mortgage Register. In the registration the mortgages have been changed to bail joint mortgages the amount of the mortgage securing the revolving credit to the amount of PLN 70,000,000.00 and payment terms to 26.02.2015 (The Company informed about change in the Current Report No. 09/2013 dated 26.02.2013). Mortgages are established in favor of Bank Handlowy SA based in Warszawa, ul. Senatorska 16. Mortgages are established on the properties situated in Polkowice, ul. Strefowa, owned by the Company and related entity, for which conducted land registers by the District Court in Lubin are as follows: No. LE1U/00037605/3, LE1U/00037607/7.

The value of established mortgages exceeds, stated in polish currency (PLN), the equivalent of 1.000.000,00. EUR

Furthermore, according to § 7 item 5 of the Ordinance of the Minister of Finance of 19 February 2009 on current and periodic information (...), the Management Board of CCC S.A. hereby informs that there is no relation between the Issuer and the Issuer's managers or supervisors, and the entity for which mortgage has been set up and its managers.
